## Membership Benefits

Full annual membership gives the benefits of full use of the BLYM fleet (subject to experience and prevailing conditions) on days when BLYM is open for general sailing, the opportunity to join expeditions to bigger water, permanent discounts at the BLYM chandlery, a full range of RYA courses, a programme of racing, regattas and events, and the regular newsletter Jibsheets.

## Concessionary Fees

Those aged 18-24 are eligible for reduced personal affiliation at £20 per year. **We are sympathetic to genuine cases of special need, and we may make discretionary arrangements for any member who may find payment of the full affiliation fee difficult.** Please contact the Membership Secretary, in confidence, to discuss this. Those joining after 30<sup>th</sup> June qualify for a 50% reduction in membership fees. This concession is not available for renewals or re-joining. Those joining after 30<sup>th</sup> September pay the following year's full subscription and pay no extra for membership in the remainder of the current year.

## Privately Owned Boats

There is a charge of £48 per boat per year for launching and storage of members' boats. Boats must be insured for third party risks to a minimum of £1million. A specific dinghy policy is recommended in preference to a household policy.

We regret the need to draw your attention to the possibility of vandalism and theft. Boats are stored and used at BLYM entirely at the owner's risk. To reduce such risks, you are advised to remove loose equipment (e.g. sails, paddles, rudder etc.) All items must be clearly and permanently marked with the owner's name. This includes hull, spars, trailer, launching trolley, wheels, etc.

In the event of any boat being abandoned at BLYM, the club reserves the right to dispose of the boat. The proceeds of sale will be regarded as a donation to the club. Boats will be regarded as abandoned in the event of subscriptions and berthing fees being over 12 months in arrears.
